

REVISED NOTICE

Reference Senate Secretariat's Notice of even number dated 22nd October, 2021. Meeting of the Standing Committee on National Health Services, Regulations and Coordination will be held on 27th October, 2021, at 11:30 a.m in Committee Room No.04, Parliament House, Islamabad. **In case of Senate session in the morning the meeting will be held at 2:30 p.m.**

 - a. It is being observed that some of the medicine factories are located in areas where other industries were installed and were in operation much before the installation of these sensitive industries. A question arises why such industries were permitted to be installed in an area where air pollution even if controlled cannot be brought down to the desirable limits.
 - b. Secondly how many times in a year the quality of medicines specially of such industries are checked and are found fit for human consumption.
 - c. What extra ordinary measures are taken by such industries so that the production and quality of the product produced are in line with the world standards.
 - vi. Implementation status of the recommendations of the committee made in its meeting held on 11th March, 2020 and 12th October, 2021 to resolve the issue of Public Petition 2872 of Mr. Sher Muhammad Hazara as per policy and merit.
