A meeting of the Senate Standing Committee on Petroleum will be held on 26<sup>th</sup> November, 2021, at 02:00 p.m. in Committee Room No. 1, at Parliament House, Islamabad. In case of Senate session in evening, the meeting will be held at 11.00 a.m.

2. The agenda of the meeting would be as under:-

- (i) Present status of Implementation of Third Party Access (TPA) to the private sector with regard to the use of LNG terminals.
- (ii) Briefing about the impediments/issues blocking the private sector's involvement in the LNG market and expected benefits or losses of its involvement in the market for consumers and the national exchequer.
- (iii) Details of contract of PLL with SNGPL for supply of LNG and amount of PLL outstanding against SNGPL or any other entity.
- (iv) The present status of Private/CNG sector's private cargo of LNG and KE deal as per CCoE and Cabinet decisions.
- (v) Briefing about the complaints of Ministries of Railways and Maritime Affairs regarding inability of Pakistan State Oil to utilize their services for oil transportation in the country.
- (vi) Briefing about margins allowed to Oil Marketing Companies and their looming financial crisis due to exchange losses, less margin, non-extension of credit by banks due to highly capital intensive model and heavy inventory losses adversely effecting foreign direct investment, infrastructure development, investment in transport, building storage capacity and maintaining an adequate stock level of petroleum products which may lead to frequent fuel shortages and the role of OGRA and Ministry of Energy in the same.
- (vii) Briefing about the steps taken/being taken by the Government to address the issues of manipulation of pricing mechanism, adulteration, misrepresentation and evasion of taxes and figure fudging across the oil supply chain identified by the inquiry commission formed in the wake of the oil crisis in 2020.
- (ix) Briefing by the Minister for Energy (Petroleum Division) regarding the reasons for delay in provision of Sui Gas to the residents of different UCs of Tehsil Muree.
- (x) Briefing by MD SNGPL regarding promotion of Sub-Ordinate Staff of Executive Cadre, including the detail of those sub-ordinate employees who were promoted and of those cases which are pending, since January, 2013.
- (xi) Briefing by MD, OGDCL regarding the Low Pressure Wells of Oil and Gas in the country, indicating Field names, Wells names, locations, current daily average production of oil in barrels and gas in MMCFD including "Reserves" in BSCF and base flow of the pressure gas.
- (xii) Point of public importance regarding non-provision of jobs to local skilled and unskilled workers of Districts Kohat, Hangu and Karak by OGDCL and M/s MOL, raised by Senator Bahramand Khan Tangi during the sitting of the Senate held on 29<sup>th</sup> September, 2021.
- (xiii) Any other items with the permission of the Chair.
