A Meeting of the Standing Committee on National Health Services, Regulations and Coordination will be held on 24th November, 2021 at 02:30 p.m. in Committee Room No.01, Parliament House, Islamabad.

2. The agenda before the Committee would be as under:-

- i. Consideration of Private Member's Bill (The Transplantation of Human Organs and Tissues. (Amendments) Bill, 2021, introduced by Senators Sana Jamali and Seemee Ezdi in the sitting of the Senate on 27th September, 2021 and referred by the House to the Committee for consideration and report.
- ii. Briefing by the Pakistan Pharmacy Council (PPC) on the following points;
 - a. Complaint by CEO Legend College, Multan against PPC on non-issuance of Accreditation/NOC to Legend College Multan and allegation of bribe for doing so. Referred by Hon'ble Chairman Senate on 4th November, 2021.
 - b. Complain submitted by Senator Rana Mahmood ul Hassan on issue of delay by PPC in registration of hundreds of pharmacies and pharmacy education institutions, despite fulfilling the requisite criteria and allegedly due to receiving of bribe/kickback.
- iii. Briefing by Ministry of National Health Services Regulation and Coordination on the following points, raised by Senator Mohsin Aziz and referred by Honorable Chairman Senate to the Committee :-
 - a. It is being observed that some of the medicine factories are located in areas where other industries were installed and were in operation much before the installation of these sensitive industries. A question arises why such industries were permitted to be installed in an area where air pollution even if controlled cannot be brought down to the desirable limits.
 - b. Secondly how many times in a year the quality of medicines especially of such industries are checked and are found fit for human consumption.
 - c. What extra ordinary measures are taken by such industries so that the production and quality of the product produced are in line with the world standards?
- iv. Constitution of Sub-Committee to look into matters of Federal Government Service Polyclinic Hospital, Islamabad
- v. Any other item with permission of the Chair.
