REVISED NOTICE



- (iv) Briefing by NHA on the cost of construction of per kilometer road with comparison between the previous government and the present government on the rate of construction of roads.
- (v) Briefing by NHA on the extreme rise in the amount of toll tax from Rs.160/- to Rs.920/- at M-2 (Islamabad – Lahore Motorway) and also submit a detail report separately on Toll Tax collection from M-1 (Peshawar - Islamabad Motorway) and M-3(Faisalabad Motorway) etc. along with its spending detail.
- (vi) Criteria/policy for allotment of restaurants at rest areas on motorway and also brief the Committee on rate list of different items price control mechanism establish by NHA.
- (vii) Briefing by the NHA on the project of beautification and plantation on the rights of way owned by NHA and also provide the details of motorway/Highways on with this project has been completed.
- (viii) Briefing by the Inspector General, National Highways and Motorway Police, regarding promotion status of DSP's, SPO's and PO's appointed in 1st Bath of 2001 alongwith the seniority list.
