- I. Further consideration of the Islamabad Capital Territory Prohibition of Interest on Private Loans Bill, 2021. [**Passed by the National Assembly and transmitted to the Senate. Senator Seemee Ezdi has laid the Bill before the Senate on 17th January, 2022.**]
 - II. Consideration of Calling Attention Notice regarding the non-development of Sector I-12 by CDA since its inception more than three decades. [**Moved by Senator Fawzia Arshad on 10th November, 2021.**]
 - III. Consideration of a Motion under rule 218 regarding the abysmal performance of CDA with respect to repair and maintenance of Govt. accommodations. [**Moved by Senator Kamran Murtaza on 17th January, 2022**]

 - d) About non-development of roads, street lights and sewerage in Sector I-11/3, Islamabad.
 - e) About overall performance of CDA for development of Islamabad.
 - f) Detailed report regarding:-
 - i. the names and locations of KACHI ABADIES in Islamabad;
 - ii. the action taken by concerned authorities to control/remove encroachments by KACHI ABADIES;
 - iii. redressal of general grievances of poor people of KACHI ABADIES;
 - iv. current status of Alipur Farash to accommodate residents of illegal KACHI ABADIES; and
 - v. Islamabad's Master plan to establish accommodations for people living in KACHI ABADIES.
 - V. Detailed report by the Inspector General of Police, Islamabad about the use of narcotics substances in the educational institutions in ICT and the steps taken by the LEAs to curb this menace.
 - VI. Any other item with permission of the Chairman.
