

I, Senator Saleem Mandiviwalla, Chairman Standing Committee on Planning, Development and Special Initiatives, have the honor to present this report of the Committee, on the Bill titled, "The Public Private Partnership Authority (Amendment) Bill, 2022", introduced by Senator Muhammad Abdul Qadir in the Senate sitting held on 7<sup>th</sup> February, 2022. Upon introduction, the Bill was referred to the Senate Standing Committee on PD&SI for consideration and report.

3. The Committee considered the Bill in its meeting held on 16<sup>th</sup> February, 2022, under the chairmanship of Senator Saleem Mandviwalla .Following Hon'ble Senators were present at the time of consideration of the Bill:-

- 4. Senator Muhammad Abdul Qadir, Mover of the Bill briefed the Committee about the objects, reasons and contents of the Bill. It was apprised that the role of elected representatives is crucial in safeguarding the interests of their electorates and also termed as voice of general public during policy formulation. He impressed upon provincialzed federal institutions to have considerable employment implications especially in the public sector. It is indeed envisaged that the proposed Amendments in Act would have positive impact on public and political representation in the Federal Government Authority which ultimately would be reflective and represented in the form of provincial diversity.
- 5. Thereafter, the Committee held extensive consideration of the Bill. The Members of the Committee supported the spirit of the Bill, however, it was proposed that number of members in the Board of the Authority from Private sector shall remain five instead of the proposed number of four. Accordingly, the members present approved following amendment to the Public Private Partnership Authority (Amendment) Bill, 2022:-

In the Public Private Partnership Authority (Amendment) Bill, 2022, in clause 2, paragraph (ii) shall be omitted and remaining clause shall be restructured accordingly.

6. In view of the above, the Committee unanimously recommends that "The Public Private Partnership Authority (Amendment) Bill, 2022", as reported by the Committee may be passed by the House. (Bill as reported by the Committee is annexed as 'A' and the Bill as introduced in the Senate



Amendment of section 6, Act VIII of 2017.- In the Public Private Partnership Authority Act, 2017 (VIII of 2017), in section 6, in sub-section, after Serial No.2, following new serials and entries related thereto, shall be inserted and entries occurring thereafter shall be renumbered accordingly:-
  - "3. one Member Senate of Pakistan Member to be nominated by Chairman Senate
    4. one Member National Assembly Member to be nominated by Speaker National Assembly"

#### AS INTRODUCED IN THE SENATE

#### A BILL

further to amend the Public Private Partnership Authority Act, 2017

It is hereby enacted as follows:-

- 1. Short title and commencement:- (1) This Act may be called the Public Private Partnership Authority (Amendment) Act, 2022.
  - (2) It shall come into force at once.
- 2. Amendment of section 6, Act VIII of 2017.— In the Public Private Partnership Authority Act, 2017 (VIII of 2017), in section 6, in sub-section (1),-
  - (i) after Serial No.2, following new serials and entries related thereto, shall be inserted and entries occurring thereafter shall be renumbered accordingly:-
    - "3. one Member Senate of Pakistan Member to be nominated by Chairman Senate
    - 4. one Member National Assembly Member to be nominated by Speaker National Assembly"
  - (ii) in the renumbered Serial No.8, in the second column, for the expression "Five members from private sector" the expression "Four members from private sector, one from each Province," shall be substituted.
