5. Chairman Committee informed that the report from the CDA and ICT, Administration on the implementation of recommendations of the Committee on Motion under Rule 218 regarding "the damage caused to lives and property due to torrential rains in Islamabad" raised by Senator Mushtaq Ahmed in the Senate has been received. Chairman Committee stated that the matter had already been deliberated and recommendations were sent to the CDA and ICT, Administration to rectify the situation. The Chairman Committee informed that the recommendations have been implemented fully and inquiries had been held and report appeared to be quite satisfactory. The Chairman Committee directed to circulate the report for information and further recommendations of the Committee, if any.

6. Senator Mushtaq Ahmed, Mover, stated that he was unable to express his satisfaction on the report due to paucity of time and he would inform after reading the report as to whether it is a satisfactory report or not.

### RECOMMENDATIONS:-

- i. Chairman Committee directed that the matter shall be treated as disposed of if Senator Mushtaq Ahmed did not convey any observation / reservations on the report by 7<sup>th</sup> January, 2022.
  - ii. The Committee recommended that Committee Members would visit under-developed sectors in Islamabad in January, 2022 so that ground realities could also be known with reference to the performance of the CDA.
