
RE-REVISED NOTICE

Reference Senate Secretariat's Revised Notice of even number dated 13th June, 2022, a Meeting of the Senate Standing Committee on Human Rights which is scheduled to be held on 23rd June, 2022 at 11:00 a.m. in Committee Room No. 1, Parliament House, Islamabad, **will now be held on 29th June, 2022 at 02:00 p.m. in Committee Room No. 4, Parliament House, Islamabad.**

2. The agenda before the Committee would remain the same i.e.:-

- I. Briefings by the Ministry of Human Rights, Ministry of Interior, National Commission for Human Rights, Chief Secretary Punjab, Chief Commissioner Islamabad Capital Territory, Inspector General of Police, Islamabad and Inspector General of Police, Punjab on the recent barbaric acts of arrest, detention, abduction, harassment and brutal assault on Parliamentarians and political workers in gross violation of the minimal requirements of a democratic government, the fundamental freedoms guaranteed under the Constitution of Pakistan (including the inviolability of dignity of man, the inviolability of privacy of the home, freedom of movement, freedom of assembly, and freedom of association), and the International Covenant on Civil and Political Rights. The briefings shall address the following specific, amongst general, points involving Police excesses and misconduct:
 - (a) Trespassing into citizens' home/private dwellings without following due process of law;
 - (b) Damaging citizens' property, including breaking down of entrance doors and gates of homes/private dwellings, and smashing windows and windscreens of vehicles; and
 - (c) Registering FIRs under Antiterrorism Act, 1997, and the Pakistan Penal Code, against unknown persons, and the related alleged abuse of legal process for subsequent political victimization.
- II. Further Consideration of "The Protection of Journalists and Media Professionals (Amendment) Bill, 2022" introduced by Senator Saleem Mandviwalla, in the Senate sitting held on 31st January, 2022.
- III. Any other matter with permission of the Chair.

3. Members are requested to kindly attend the meeting. During the meeting the social distancing and precautionary measures as per SOPs against COVID-19 shall be observed.
