

Subject: REPORT OF THE SENATE COMMITTEE ON RULES OF PROCEDURE AND PRIVILEGES ON THE PRIVILEGE MOTION MOVED BY SENATOR ATTA UR REHMAN REGARDING THE BREACH OF PRIVILEGE BY CDA ON ACCOUNT OF NON-COMPLIANCE TO THE DIRECTIONS OF SSC ON INTERIOR CONCERNING ALLOTMENT OF RESIDENCE TO KHATEEB AND IMAM MASJID OF F-6/1, ISLAMABAD.

I, Senator Muhammad Tahir Khan Bizinjo, Chairman Senate Committee on Rules of Procedure and Privileges, have the honor to present report of the Committee on the Privilege Motion moved by Senator Atta Ur Rehman regarding the breach of privilege by CDA on account of non-compliance to the directions of SSC on Interior concerning allotment of residence to Khateeb and Imam Masjid of F-6/1, Islamabad.

2. The Privilege Motion was moved by Senator Atta Ur Rehman in the Senate sitting held on 1st February, 2022 which was referred to the Committee from the Secretariat on 3rd February, 2022 for consideration and report.

Joint Secretary (CDA), Ministry of Interior and Director General (Admin.) CDA were also present in the meeting.

5. The Mover was not present. However, the Khateeb of Parliament House Mosque who was present was allowed by the Committee to brief the issue in detail. He briefed the Committee about the grievances; however, he informed that his grievances have almost been resolved.


6. Mr. Naveed Tareen, Director General (Admin.) CDA briefed the Committee about the issues raised in the Privilege Motion. He informed that the allotment of House of Khateeb Parliament House Mosque was cancelled in the year 2019 under the Rules due to the reason that he has his own house in Islamabad. He further informed that now his allotment has been restored and the House has been designated for the Khateeb. He also informed the Committee that his grievance regarding time scale promotion has also been redressed which will be notified soon. The Committee appreciated D.G (Admin.) CDA for the progress in redressal of grievances.

7. As far as the grievance of the Khateeb regarding the designation of the House for religious education is concerned, the Committee was informed that the same cannot be done under the rules. The Committee also agreed that a residential House cannot be designated for religious education of girls/boys.

8. **The Committee unanimously decided that since the grievances have been redressed/resolved, therefore, the Privilege Motion may be disposed of.**

9. In view of the above recommendation, the Committee also gave approval for presentation of report to the House. Hence, this report is presented to the House.
