Muhammad Khalid, Major Saeed Ahmad, Major Muhammad Talha Manan and Naek Mudassar Fayyaz who lost their lives in the line of duty as a result of a tragic helicopter crash while monitoring the flood relief operations in Balochistan on 1 st August, 2022. While honoring the services and sacrifice of these martyrs for national cause, the Hous families of the e expresses deep sympathies and condolences with the bereaved Shuhada .

The Senate of Pakistan appreciates the relief operations of Pakistan armed forces in the flood affected areas of the country specially Balochistan.

The Senate of Pakistan also acknowledges the sacrifices being rendered by the armed forces for the security and the defence of Pakistan and during natural calamities."
