The following Acts of Parliament received the assent of the President on the June, 1985, and are hereby published for general information :—

ACT No. II OF 1985

An Act further to amend the Chairman and Speaker (Salaries, Allowances and Privileges) Act, 1975

WHEREAS it is expedient further to amend the Chairman and Speaker (Salaries, Allowances and Privileges) Act, 1975 (LXXXII of 1975), for the purposes hereinafter appearing :

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the Chairman and Speaker (Salaries, Allowances and Privileges) (Amendment) Act, 1985.

(2) It shall come into force at once and shall be deemed to have taken effect on the first day of March, 1985.

2. Amendment of section 3, Act LXXXII of 1975.—In the Chairman and Speaker (Salaries, Allowance and Privileges) Act, 1975 (LXXXII of 1975), hereinafter referred to as the said Act, in section 3, for the words “four thousand rupees” the words “seven thousand rupees” shall be substituted.

3. Amendment of section 4, Act LXXXII of 1975.—In the said Act, in section 4, for the words “two thousand rupees” the words “four thousand rupees” shall be substituted.

4. Amendment of section 6, Act LXXXII of 1975.—In the said Act, in section 6, for the words “one thousand rupees” the words “three thousand rupees” shall be substituted.

5. Amendment of section 8, Act LXXXII of 1975.—In the said Act, in section 8,

(a) in sub-section (1), for the proviso the following shall be substituted, namely :—

“ Provided that half of the electricity and gas charges in excess of one thousand rupees per mensem shall be paid by the Chairman or, as the case may be, the Speaker.”;

(b) after sub-section (1), amended as aforesaid, the following new sub-section shall be inserted, namely :—

“(1A) The assessed rent of house hired for the use of the Chairman or the Speaker shall in no case exceed eight thousand rupees per mensem.”;

- (c) in sub-section (2), for the words "thirty thousand rupees" the words "sixty thousand rupees" shall be substituted;
- (d) in sub-section (3), for the words "one thousand two hundred and fifty rupees" the words "eight thousand rupees" shall be substituted; and
- (e) in sub-section (4), for the words "one thousand two hundred and fifty rupees" the words "eight thousand rupees" shall be substituted.

6. **Amendment of section 9, Act LXXXII of 1975.**—In the said Act, in section 9,—

- (a) in sub-section (2), in clause (b), for the words "fifty rupees" the words "one hundred and fifty rupees" and for the words "twenty-five rupees" the words "seventy-five rupees" shall be substituted;
- (b) in sub-section (3), in clause (b) for the words "fifty rupees" the words "one hundred and fifty rupees" and for the words "twenty-five rupees" the words "seventy-five rupees" shall be substituted; and
- (c) in sub-section (5), for the words "one rupee per mile" the words "two rupees per kilometre" and for the words "seventy-five paise per mile" the words "one rupee and fifty paise per kilometre", and for the words "fifty rupees" the words "one hundred and fifty rupees" shall be substituted.

7. **Amendment of section 17, Act LXXXII of 1975.**—In the said Act, in section 17, in sub-section (2), for the words "four thousand rupees" the words "seven thousand rupees" shall be substituted.
