The following Acts of Parliament received the assent of the President on the 26th September, 1973, and are hereby published for general information :—

ACT No. LXIX OF 1973

An Act further to amend the Companies Act, 1913

WHEREAS it is expedient further to amend the Companies Act, 1913 (VII of 1913), for the purposes hereinafter appearing :

It is hereby enacted as follows :—

1. Short title and commencement.—(1) This Act may be called the Companies (Amendment) Act, 1973.

(2) It shall come into force at once.

2. General amendment, Act VII of 1913.—In Companies Act, 1913 (VII of 1913), hereinafter referred to as the said Act, for the words “Central Government” wherever occurring the words “Federal Government” shall be substituted.

3. Amendment of section 248, Act VII of 1913.—In the said Act, in section 248, for sub-section (5) the following shall be substituted, namely :—

“(5) Any person may inspect the documents kept by the registrar on payment of such fees as may be appointed by the Federal Government, not exceeding one rupee for each inspection, and any person may require a certificate of incorporation or certificate of commencement of business of any company, or a copy or extract of any other document or any part of any other document, to be certified by the registrar on payment for the certificate, certified copy or extract, of

such fees as the Federal Government may appoint, not exceeding five rupees for a certificate of incorporation or commencement of business, and not exceeding seventy-five paise for every hundred words or fractional part thereof required to be copied, subject to a minimum fee of five rupees for each copy or extract."

4. **Amendment of section 277, Act VII of 1913.**—In the said Act, in section 277, sub-section (8) shall be omitted.

5. **Amendment of First Schedule, Act VII of 1913.**—In the said Act, in the First Schedule, for Table B the Table set out in the Schedule to this Act shall be substituted.

TABLE OF FEES TO BE PAID TO THE REGISTRAR

1. By a company having a share capital

3. For registration of any increase of share capital made after the first registration of the company, the same fee per 10,000 rupees or part of 10,000 rupees, as would have been payable if such increased share capital had formed part of the original share capital at the time of registration.	
4. For registration of any existing company, except such companies as are by this Act exempted from payment of fees in respect of registration under this Act, the same fee as is charged for registering a new company.	
5. For filing any document by this Act required or authorised to be filed, other than the memorandum or the abstract required to be filed with the registrar by a receiver or the statement

II. By a company not having a share capital, other than a company registered under a licence granted under section 26.	
1. For registration of a company whose number of members, as stated in the articles of association, does not exceed 20 .. .	100.00
2. For registration of a company whose number of members, as stated in the articles of association, exceeds 20, but does not exceed 100	250.00
3. For registration of a company whose number of members, as stated in the articles of association, exceeds 100, but is not stated to be unlimited, the above fee of Rs. 250 with an additional Rs. 12.50 for every 50 members, or less number than 50 members, after the first 100.	
4. For registration of a company in which the number of members is stated in the articles of association to be unlimited, a fee of	1,000.00
5. For registration of any increase on the number of members made after the registration of the company, the same fees as would have been payable (in respect of such increase) if such	

increase had been stated in the articles of association at the time of registration : Rs. Paisa

Provided that no one company shall be liable to pay on the whole a greater fee than Rs. 1,000 in respect of its number of members taking into account the fee paid on the first registration of the company.
