

The Committee held discussion regarding Question No. 97 asked by Senator Mohsin Aziz in the Senate sitting held on 11<sup>th</sup> February 2022, pertaining to the collection of income tax from the industrial sector in Sindh during the last three years. Senator Mohsin Aziz informed the Committee that the purpose of this question was to ascertain the actual tax collection of province because ports are located in Sindh where duty is collected for goods destined for other provinces. Therefore, it is an important question for federation to determine how much each federating unit is contributing towards taxes. Considering this is an important NFC matter, State Minister for Finance replied that it's a head quarter problem. For tax purposes FBR can only tax the head quarter and it is impossible to segregate it according to other provinces. After detailed deliberations, Senator Mohsin Aziz was satisfied with the response of FBR as his purpose was to determine the year wise income tax collected from industrial sector in Sindh Province during the last three years to have a realistic idea about the actual tax collection by Sindh vis-à-vis the rest of the country and the agenda was disposed of.
