

The agenda was taken up by the Committee regarding Question No. 100 asked by Senator Mohsin Aziz in the Senate sitting on 11th February 2022, pertaining to the collection of regulatory duty on the imports of goods imported through Karachi Port in the last three years. Senator Mohsin Aziz mentioned that we should know the province-wise contribution of taxes, as Karachi is working as a tax/duties collector rather than tax payer, due to the presence of sea ports. Goods destined for the industry of other provinces are taxed here at the ports with regard to custom duty, sales tax, federal excise duty and income tax. He highlighted that in terms of income tax collection, the contribution of Karachi city is only 16% and the province of Sindh contributes Rs. 225 billion towards the total collection of Rs. 2,280 billion from Pakistan. After detailed deliberations, Senator Mohsin Aziz was satisfied with the response of FBR as his purpose was to determine the regulatory duty collected on imports of goods imported through Karachi ports to have a realistic idea about the actual collection by Sindh vis-à-vis the rest of the country and the agenda was disposed of
