4. Director General, Federal Government Education Institution (FGEI) apprized the Committee that Recruitment Rules of SST (BS-17) were formulated in 2017 under which new post


of SST was created and five cadres were merged. The process was twice challenged in the Federal Services Tribunal (FST), Islamabad, first in 2019 and subsequently in 2021 with last hearing held in September, 2022. Moreover, Establishment Division had advised FGEI to fix the seniority as per entry into the grade.


5. Director General, FGEI further added that upon receipt of Establishment Division, advise/opinion regarding fixation of seniority of merged cadres, process to finalize seniority of SSTs (BS-17) had been expedited. Seniority would now be fixed as per date of entry into grade and final outcome of court case. Efforts were being made to grant time scale/regular promotion to the SSTs (BS-17) on immediate basis after finalization of seniority lists.

6. The Committee was informed that FGEI granted time scale promotion to various cadres/grades with effect from 2017 as per following details:
