**BILLS AS PASSED BY THE NATIONAL ASSEMBLY**

**1. Senator Shahadat Awan, Minister of State for Law and Justice** on behalf of **Rana Sana Ullah Khan**, Minister for Interior, moved that the Bill further to amend the Islamabad Capital Territory Local Government Act, 2015 [The Islamabad Capital Territory Local Government (Amendment) Bill, 2022], as passed by the National Assembly, be taken into consideration.

**The Motion was put to the House and adopted. Thereafter, the House started second reading of the Bill i.e. clause by clause consideration.**

**2. Senator Shahadat Awan, Minister of State for Law and Justice** on behalf of **Rana Sana Ullah Khan**, Minister for Interior, moved that the Bill further to amend the Islamabad Capital Territory Local Government Act, 2015 [The Islamabad Capital Territory Local Government (Amendment) Bill, 2022], be passed.
