3. The Committee considered the matter and held conclusive in its meeting held on 10th October, 2022, under the Chairmanship of Senator Hidayat Ullah, with the following in attendance:

To the matter of Transfer of dead bodies from abroad through PIA, Senator Azam Khan Swati briefed the Committee about the incident of delayed flight on 14th August, 2022. He highlighted the negligence and inhuman behavior of PIA on ground staff of Dubai International airport, with Passengers of flight (PK212), en-route to Islamabad. It was apprised that the flight was 18-30 hours late and two dead bodies were booked in the same flight. Senator Azam Khan Swati showed grave concerns on the behavior of PIA staff and asked for stringent action against the culprits. PIA official informed the Committee that the aircraft was declared (AOG) by the Engineering as Flight PK 212 developed a technical issue before the pushback; therefore, all passengers were disembarked from the aircraft. PIA offered valid resident holders the option to travel from Sharjah and 27 passengers agreed to travel through Sharjah on PK 182/14 August (Sharjah-Islamabad), whereas, rest of the passengers were made to stay in the departure lounge. The dead bodies booked with the flight were sent to cold storage in the cargo section. The passengers were served breakfast, lunch and refreshments, while, the premium economy class passengers were sent to Marhaba lounge. The flight was cleared at 16:00 LT by engineering and departed at 18:40 LT. CEO PIA informed the Committee that after completing the inquiry, Mr. Noor Shan and Mr. Saeed Gul, PIA employees, working at Dubai airport, had been issued explanation letters. Upon receiving their replies, PIA management has issued warning letters. Furthermore, both the employees have been suspended and advised to report at Town Office Dubai. Country Manager has been advised to evaluate their retention or otherwise as per local labor laws and the case for their termination may also be



considered. Outcome of the same will be submitted to the Committee accordingly.

- 5. The Committee disposed-off the matter with the directions that stern action should be taken against the culprits under intimation to the Committee so that such incidents may not occur in future.
- 6. The Committee disposed-off the matter for onward report to the House.
