

# REPORT OF THE SENATE STANDING COMMITTEE ON MARITIME AFFAIRS UNDER PROVISO TO SUB-RULE (4) OF RULE 166 OF THE RULES OF PROCEDURE AND CONDUCT OF BUSINESS IN THE SENATE, 2012

- I, Senator Rubina Khalid, Chairperson Senate Standing Committee on Maritime Affairs, have the honour to present the report, on behalf of the Committee, on the budgetary allocation and its utilization by the Ministry of Maritime Affairs and its attached departments during first six months of financial year 2022-23, under proviso to sub-rule (4) of Rule 166 of the Rules of Procedure and Conduct of Business in the Senate, 2012.

3. The Committee considered the budgetary allocation and its utilization during first six months of financial year 2022-23, in respect of the Ministry of Maritime Affairs and its attached departments, in its meeting held on 26<sup>th</sup> January, 2023. 4. Mr. Masood Ahmad, CFO&AO informed the Committee that total budget allocation of the Ministry of Maritime Affairs for the financial year 2022-23 is Rs. 1,177.8 million and a Technical Supplementary Grant of Rs. 822.750 million has been disbursed directly to the Gwardar Port Authority for distribution among the poor fishermen of Balochistan for purchase of boat engines. He said that Finance Division released 10% less funds during first six months of financial year 2022-23 and the

Ministry was spending the budget with utmost care. He told that the budget allocated to different departments and expenditure made upto 31st December, 2022 was as under:-

- 5. Syed Masood Abbas Rizvi, MD, Korangi Fisheries Harbour Authority (KoFHA) informed the Committee that following three development projects of KoFHA were conditionally approved by the CDWP in its meeting held on 15-04-2020:
  - i) Establishment of Business Park at Korangi Fish Harbour
  - ii) Establishment of Cold Storage and Freezing Tunnels
  - iii) Modification of Auction Hall

He said that the CDWP had approved the projects at the cost of 784.0 million, 170.1 million and 94.51 million respectively (all Japanese Grant in Aid) with the direction that before initiating works on the projects, the updated feasibility study and firmed-up cost estimates on the basis of detailed design will be submitted by the sponsors to the Planning Commission. He told that KoFHA has hired the services of M/S NESPAK for Planning, designing and resident supervision of the projects and the preparation of revised PC-I of above projects is in final stages. He added that revised PC-I and firmed-up cost estimates would soon be forwarded to the Ministry for further processing. The Committee was told that an amount of Rs.245.861 million was allocated in PSDP 2022-23 for "Establishment of Business Park at Korangi Fish Harbour", an amount of Rs.41.928 million was allocated in PSDP 2022-23 for "Establishment of Cold Storage and Freezing Tunnels" and an amount of Rs. 5.743 million was allocated in PSDP 2022-23 for "Modification of Auction Hall". The CFO&AO, Ministry of Maritime Affairs clarified that Finance Division has not disbursed the allocated funds for these projects so far and there is no physical and financial progress on these projects so far. The Committee was informed that the revised estimated cost of project "Establishment of Business Park at Korangi Fish Harbour" has been worked out by M/S NESPAK at Rs.4301.234 million, revised estimated cost of project "Establishment of Cold Storage & Freezing Tunnels" is Rs. 626.254 million and revised estimated cost of project "Modification of Auction Hall" is Rs. 643.288 million. The Committee recommended the Ministry and KoFHA to finalize the revised PC-Is of the three development projects at the earliest possible and forward these to the concerned ministries/divisions for immediate processing/approval.
