    - g) The time by which Allotment Letters will be issued to the members belonging to Constitutional Quota.
  - iv. Briefing by the Director General (Estate) to the Committee on the following:-
    - a) To provide fresh detail of all the officials (BPS-14 and above) of Ministry of Housing & Works, Estate Office, FGEHA, PHA and Pak PWD about non-ownership of any flat or house in Islamabad and also their assets.
    - b) Fresh affidavits may be obtained from all the allottees of F-type/ Cat-II from above regarding the non-ownership of any flat or house in their name and in their spouses' names in Islamabad.
