

 - i. Submission of Budgetary proposals relating to Public Sector Development Programme (PSDP) for the Financial year 2023-24 to the Senate Standing committee.
 - ii. The Ministry to brief the Committee on the progress made in relation to recovery of cotton cess from the Textile Industry which is the main source of cotton research.
 - iii. Whether dues of salaries and other allowances have been paid to the employees of the Pakistan central cotton committee (PCCC).

Whether the recruitment has been made in accordance with the law?

 - a. Development of the high value camel milk powder to earn foreign exchange and improve livelihood of arid area of Pakistan;
 - b. Thar Community Actions for the Management of Sustainable Eco-System, Livestock, land & Livelihood (THAR CAMEL);
 - c. Induction of high value date palm varieties and establish processing plant to increase revenue by export for Pakistan
