2. The composition of the Committee is as under:-



The Committee considered the matter in its meetings held on 20<sup>th</sup> January, 8<sup>th</sup> June, 28<sup>th</sup> July and 25<sup>th</sup> August, 29<sup>th</sup> September and held conclusive in its meeting held on 10<sup>th</sup> October under the Chairmanship of Senator Hidayat Ullah, with the following in attendance:



4. The Committee took up the matter regarding posts held by DG Civil Aviation Authority during last 15 years including designation, tenure and places of postings. Senator Naseeb ullah Bazai, asked whether DG CAA has served in the hard areas i.e FATA, KPK and Balochistan during his tenure as per policy of the Establishment Division as his post requires multidimensional experience of hard areas. The Director General apprised the Committee about his postings in Punjab and Sindh during last 15 years; however, he informed that he never served in Balochistan. Special Secretary, Establishment Division apprised the Committee that as per policy of Establishment Division, Officers likely to be considered for promotion to BS-20 are required to serve in Balochistan for two years in BS-19 or BS-20 before or after actualization of their promotion to BS-20 as the case may be, however, the current DG did not serve in the hard areas.

5. The Committee showed reservation on the mechanism adopted for appointment of DG CAA as he did not serve in the hard areas of Balochistan. However, after detailed deliberations, disposed of the matter by directing Ministry of Aviation to expedite the process of passing of Pakistan Civil Aviation Bill 2021 and Pakistan Airport Authority Bill 2021 currently lying pending with National Assembly so that a professional having relevant experience and skills in the Aviation field could be appointed.
