

The Committee considered the matter in its meetings held on 20<sup>th</sup> January, 8<sup>th</sup> June, 28<sup>th</sup> July and 25<sup>th</sup> August, 29<sup>th</sup> September and held conclusive in its meeting held on 10<sup>th</sup> October under the Chairmanship of Senator Hidayat Ullah, with the following in attendance:

4. The Committee took up the matter regarding the service/group of the current DG, Civil Aviation Authority and substantive pay scale. Ministry of Aviation informed the Committee that the Current Director General, Civil Aviation Authority (CAA), was posted by Federal Government, and he is an officer of Pakistan Administrative Service in BS-21. To the question of serving of current DG CAA in the hard areas of Balochistan, the Special Secretary, Establishment Division apprised the Committee that as per policy, Officers likely to be considered for promotion in BS-20 are required to serve in Balochistan for two years in BS-19 or BS-20 before or after actualization of their promotion in BS-20 as the case may be, however, the current DG did not serve in the hard areas of Balochistan.

5. The Committee showed reservation on the non-serving of the current DG, CAA in the hard areas of Balochistan. However, disposed off the matter while directing Ministry of Aviation to expedite the process of passing of Pakistan Civil Aviation bill 2021 and Pakistan Airport Authority Bill 2021 bill currently lying pending with National Assembly so that a professional having relevant experience and skills in the Aviation field could be appointed.
