INTRODUCED ON 20.02.2023

[AS INTRODUCED IN THE SENATE]

A BILL

further to amend the Civil Servants Act, 1973

WHEREAS It is expedient further to amend the Civil Servants Act, 1973 (LXXI of 1973) for purposes appearing and for matters ancillary thereto;

It is hereby enacted as follows:-

- 1. Short title and commencement. (1) This Act may be called the Civil Servants (Amendment) Act, 2023.
 - (2) It shall come into force at once.
- 2. Amendment of section 14, Act LXXI of 1973.- In the Civil Servants Act, 1973 (LXXI of 1973), in section 14, for sub-section (1) the following shall be substituted, namely:-
 - "(1) A retired civil servant shall not be re-employed under the Federal Government by any means of employment including extension, re-employment, contract, consultancy, ad-hoc and temporary basis, contingent paid, project, specialized (including MP scales) posts, and for autonomous bodies, semi-autonomous bodies, corporations, companies, authorities or by any other approval of the authority with or without the prescribed procedure."

STATEMENT OF OBJECTS AND REASONS

The qualifications, experience, credentials or skills of the employee are such that no one is more suitable than him for appointment to that position — or simply that person is fittest to that position on an open merit after the job has been offered to all citizens equally without discrimination instead of the only retired employees.

All employments have to be in public interest, the principles of open merit, transparency, and equality of opportunity need to be observed leading to the selection of the most suitable candidate.

The re-employment of civil servants should not become the rule. A civil servant has legitimate expectation to be promoted to the higher grade or position provided that he fulfills the relevant criteria laid down by the law. However, that legitimate expectation

is denied when another civil servant who after he has reached the age of superannuation is re-inducted against a senior post. In the second place, contract employment creates anomaly in the functioning of a ministry or department. If the person occupying the top position is a contract employee, and therefore not a civil servant, while his post is permanent and the subordinate officials are also permanent employees. In the third place, the re-hiring of retired civil servants makes for political interference in the working of civil services. In most of the cases, the officials are offered reemployment on the basis of their political connections. Such officials find it difficult to resist political pressure, mainly because they owe their job entirely to the political masters. In the fourth place, contract employment brings ad-hocism to the working of civil services, which runs counter to its basic character. As opposed to the political executive or ministers, civil servants are called the permanent executive, because they hold office for a long period and are not sent home with change in government. So, all other modes other than the prescribed rules of regular services need to be discouraged.

The Bill has been designed to achieve the above purpose.
