

NOTICE

A meeting of the Senate Committee on Rules of Procedure and Privileges will be held on **Thursday, the 21st September, 2023 at 2:30 p.m. in Committee Room No.1 Parliament House, Islamabad.** *In case of Senate session, the meeting will be postponed.* The agenda before the Committee would be as under:

- I. Consideration of Privilege Motion moved by Senators Fida Muhammad, Prince Ahmed Umer Ahmed Zai and Shamim Afridi against the then Secretary Petroleum Division (now posted as Secretary M/O National Food Security and Research) for inappropriate and rude behavior with the members of the Committee during meeting of the Standing Committee on Petroleum held on 2nd May, 2023. The Members have stated that due to inappropriate behavior of the Secretary Petroleum during the meeting, the proceedings of the Committee could not be held in a smooth manner which amounts to breach of privilege of the Committee. The matter referred by the Hon'ble Chairman Senate on 25th June, 2023.
- II. Consideration of Privilege Motion moved by Senator Saifullah Abro against Mr. Imran (SP Larkana), Mr. Atiq Mekan (SP Larkana), Asad Bhatti (DSP Civil Lines), Sartaj Jagirani (SHO Market), Muhammad Mangiro (SHO Hyderi), SHO Civil Lines, SHO Dari, SHO Taluka 15 who raided the House of Hon'ble Senator without any warrant along with more than 200 police personnel and 20 police mobiles. The Hon'ble Senator has alleged that the police party vandalized his property, beaten and threatened his employees and guards, violated the sanctity of Chaddar and Char Devari which tantamount to breach of his privilege as Member of the Senate of Pakistan. The matter referred by the Hon'ble Chairman Senate on 10th August, 2023.
- III. Consideration of Privilege Motion moved by Senator Sardar Muhammad Shafiq Tareen against Mr. Sajjad (JS Org.) M/O S&T, Dr. H.U Khan (DG, PSQCA) and Syed Ali M. Bukhari (Director Admin PSQCA) for disobedience of the directions of the Committee in the matter of irregularities in the recruitment process in PSQCA and for using derogatory remarks for the Committee. The matter referred by the Hon'ble Chairman Senate on 10th August, 2023.
