- 4. Senator Taj Haider, Chairman, Standing Committee on Parliamentary Affairs at the outset briefed Members of the Committee on a Starred Question No. 48raised in the House regarding appointments made in the Election Commission of Pakistan (ECP) since July, 2020 and referred by the House to the Committee for consideration and report.
- The Mover of the Starred Question No. 48, Senator Saifullah Sarwar Khan Nyazee, submitted to the Committee that the answer submitted by the Election Commission of Pakistan (ECP) before the Committee on the appointments made since July, 2020 with province wise break-up and details of terms and conditions of contract and salary, perks and privileges granted to employees of ECP is comprehensive and complete. The Committee, thereafter, disposed of starred question No. 48 with the recommendation to place the report of the Committee in the House along with the details of appointments in ECP since 2020 and their province wise breakup etc.(Annexure-A), as shared by the Election Commission of Pakistan (ECP).

 - (iv) retention of the retiring officer, for a specified period, is in the public interest.
