- v. How many schemes have been included in PSDP for the year 2023-24 from new proposals submitted by the Ministry including three projects proposals submitted by AZRC Umerkot for funding from PSDP.
- vi. Progress report in relation to recommendations of the committee for establishment of following three projects:
  - Development of the high value camel milk powder to earn foreign exchange and improve livelihood of arid area of Pakistan.
  - Thar Community Actions for the Management of Sustainable Eco-System, Livestock, land & Livelihood (THAR CAMEL).
  - c. Induction of high value date palm varieties and establish processing plant to increase revenue by export for Pakistan.
- vii. The Cotton Commissioner to brief the committee whether any new verities of cotton seed have been evolved which are pest resistant and drought resistant.
- viii. The D.G Plant Protection Department to submit complete report in the light of the directions given by the committee in the meeting held on 16th February, 2023 about the filling up vacancies in Plant Protection Department during the last two years with information including total number of vacancies advertised, number of candidates tested/short listed for interviewed, marks obtained and Domicile of candidates. Whether the recruitments have been made in accordance with the law?
- ix. The Chairman PARC to inform the committee for the PC-IV for the PSDP project ended in June 2023 executed at PARC/AZRC Umerkot, what is the status of project regularization to continue to unique/high value bio-saline research and development activities for the uplifting of the desert area.
- x. The PARC/AZRI Umerkot was upgraded as (Arid Zone Research Center) Umerkot on 24.11.2021 but its administrative control has not yet been notified. The time by which the PARC will notify Administrative control of this centre like other centers on the same line?
