CALLING ATTENTION NOTICES

1. Senator Kamran Murtaza, to draw attention of the Minister for Aviation towards disruption of PIA's Flight operation due to stoppage of fuel supply by the contractors on account of non-payment of their dues and some other operational issues which resulted into cancelation of dozens of domestic and international flights on 18th October, 2023 causing great hardships and difficulties to the passengers.
