- VIII. The Secretary Ministry of Interior to brief the Committee on the following:
  - a) About the incidents of stopping and offloading of Parliamentarians from flights even of those who were proceeding abroad on official visits.
  - b) The mechanism and SOPs of including the name of any person in ECL, No Fly List, Black List, PNICL or any other travel restriction list and the SOPs of informing the person whose name is included in such lists.
  - c) **Number of PB and NPB arms licenses issued by the Ministry of Interior during last one year with particular details of such licenses issued during the caretaker Government.**
  - d) **Number of PB and NPB licenses issued to the Parliamentarians during last one year with particular details of such licenses issued during the caretaker Government.**
- IX. Consideration of **Public Petition No.5316** regarding non-issuance of Notification of upgradation of the post of Database Administrator from BPS-17 to BPS-18 and induction of services in regular cadre as per section 41 of NADRA Ordinance. **(Matter referred by the Hon'ble Chairman Senate)**



X. The Senior Management of the Federal Residents' Cooperative Housing Society, Islamabad to brief the Committee on following points:

- a) what are the byelaws of the society since its inception in 1996 till now, whether the starting byelaws provide powers to contest private person in the society election, if not, the time by which the said byelaws were changed and indicate also the year along with names of the management who did the same with complete details.
- b) Up to date status of current management whether they had been elected or selected along with their membership status.
- c) The details / number of cases/enquiries registered or pending against the Management of the Society along-with its up-to-date status till its inception.
- d) Up to date list of Senate Employees who had deposited their cost of land and development charges with name and instalment-wise details.
- e) Up to date list along-with names of allottees of Block D who had cleared their dues and those who had not paid their dues, separately, along-with installment-wise details and the time by which the possession of land will be handed over to allottee. The Chairman Committee further directed that repeated direction to provide possession to eligible allottees but the same had not been fulfilled in Block D due to non-development which is a sheer violation and a detailed report should be submitted for negligence by the management.
- f) Up to date list/detail of amounts received from the members/allottees till date, separately, with installment wise details.
- g) Details of demarcation of LOP along-with the time by which the tender of the bridge will be advertised.
- h) Up to date status of land (developed/un-developed) available with the society with block-wise details along-with current status of land available for possession.
