4. Honourable Senator Shahadat Awan, Mover of the Bill apprised he committee about the objects and reasons of the Bill he presented in the House. He stated that in order to bring law in conformity with the global best practices, the amendment proposed by him is aimed to prescribe qualifications for the private members, with and aim to ensure competence and effective management of affairs and responsibilities of the Board as well as Public Procurement



Regulatory Authority. The Chairperson raised an observation about mentioning of a person of integrity which she pointed out that integrity is a subjective question. The mover of the amendment agreed that word integrity should be deleted. The Committee proposed the following amendments in the Bill introduced by Senator Shahadat Awan" (4A) The Members referred to in entry (7) of sub-section (2), shall be a person possessing qualifications, and at least fifteen years' experience in public administration, economics, Law, finance, engineering or related technical fields."

After detailed discussion, the Chairperson decided to put the Bill to vote, whereupon the Committee passed the Bill with amendments (copy annexed as "B"). The Committee approved presentation of report in the House.

further to amend the Public Procurement Regulatory Authority Ordinance, 2002

WHEREAS it is expedient further to amend the Public Procurement Regulatory Authority Ordinance, 2002 (XXII of 2002), for the purposes hereinafter appearing;

It is hereby enacted as follows:-

- 1. Short title and commencement. (1) This Act may be called the Public Procurement Regulatory Authority (Amendment) Act, 2023.
 - (2) It shall come into force at once.
- 2. Amendment of Section 6, Ordinance XXII of 2002.- In the Public Procurement Regulatory Authority Ordinance, 2002 (XXII of 2002), in section 6, after sub-section (4), the following new sub-section shall be added, namely,-


"(4A) The Members referred to in entry (7) of subsection (2), shall be the persons of integrity, possessing qualifications, and at least fifteen years' experience in public administration, economics, legal matters, finance, engineering or related technical fields."
