MOTION **[Under Rule 263]**

2. **SENATOR MUHAMMAD ISHAQ DAR**, Leader of the House and **SENATOR SYED SHIBLI FARAZ**, Leader of the Opposition, to move under Rule 263 of the Rules of Procedure and Conduct of Business in the Senate, 2012, that the requirement of Rule 41 of the said Rules regarding question hour be dispensed with for the whole current session.

MOTION **[Under Rule 204]**

3. **SENATOR MUHAMMAD ISHAQ DAR**, Leader of the House and **SENATOR SYED SHIBLI FARAZ**, Leader of the Opposition, to move under Rule 204 of the Rules of Procedure and Conduct of Business in the Senate, 2012 that the House may authorize the Honourable Chairman Senate to appoint a Special Committee to examine the Money Bill, the Tax Laws (Amendment) Bill, 2024 and present its recommendations thereon to the House.
