  - d) The number of complaints received during last one year regarding overbilling and current status of those complaints
  - e) Total number of employees including regular, contractual and daily wagers along with their pay-scales.
  - f) The details of authorized workshops (public/private) functioning under SEPCO with feeder-wise detail of transformers which got damaged and subsequently repaired during last one year; percentage of complaints resolved during last one year; and criterion of shortlisting of private workshops involved in repair/maintenance.
- iv. The Secretary Power Division and the Chairman NEPRA to brief the Committee on the following points pertaining to Bagasse based power projects:
  - a) The number of Bagasse based IPPs operating in the country.
  - b) The basis of their tariff determination.
  - c) What is the total installed capacity of Bagasse based power projects?
  - d) What is the pass through cost of Bagasse based power projects
  - e) The reasons of working out of Bagasse price and corresponding FCC on the basis of price of the imported coal (South African) using heating and value of both fuels?
  - f) What are the terms & conditions of Upfront Tariff for the Bagasse based projects?
- v. Any other item with the permission of the Chair.
