    - a) Steps taken for management improvement and arrangements for security and safety for the commuters.
    - b) Death case of Maryam Bibi of Jaranwala, in which Constable Mir Hassan abused her and her children aboard the Millat Express.
  - v) Detailed briefing / presentation on the Thar Rail Connectivity Project;
