REVISED NOTICE

In continuation of Senate Secretariat Notice of even No. dated 17th October, 2024. The meeting of the Senate Standing Committee on Housing and Works will be held on 29th October, 2024, at 11:00 a.m. in Committee Room No. 4, Parliament House, Islamabad. In case of Senate Session in the morning the meeting will be held at 2:30 p.m.

- (4) Comprehensive presentation on:
 - (i) **(a)** various membership drives since 2007; **(b)** total number of members in each membership drive; **(c)** reasons for giving priority to membership on 'age seniority' over the membership on 'first-come-first-serve' basis in housing schemes launched after the latter membership drive; **(d)** number of members in these two membership categories who have been given allotments or registered/listed for allotments in any housing scheme; **(e)** number of members in both membership categories who are not listed/registered in any housing scheme; and **(f)** the housing schemes in which the first-come-first-serve members will be given allotments.
 - (ii) Payments made to land owners of sectors F-12 and G-12.
 - (iii) Thalliyan scheme; funds received and current deposits status against this scheme; JVs/partnerships; causes for failure; and inquiries/actions taken in the matter;
 - (iv) Park Road scheme.

- (5) Status of inquiries/cases in FIA against Pak PWD, FGEHA, PHA-F and NESPAK
- (6). Any other matter(s) with permission of the Chair.
