2. The agenda of the meeting will be as under:

- I. Consideration of a point of public importance raised by Senator Aimal Wali Khan in the House on 9th September, 2024 regarding the inclusion of IPPs fee in the electricity bills by PESCO in Khyber Pakhtunkhwa whereas not a single unit of electricity is being produced by IPPs in the province of Khyber Pakhtunkhwa. **(Matter referred from the House).**
- II. Consideration of a matter referred by the Hon'ble Chairman Senate regarding false/incorrect reply submitted by PESCO in response to question No.22 asked by Senator Kamran Murtaza on 30th August, 2024 about installation of additional transformer of 100 KV in village Garh Bala.
- III. The Chief Executive Officer of QESCO to brief the Committee on the following points:
 - a) The feeder-wise detail of scheduled and unscheduled load-shedding of electricity during last two months. The detailed chart showing daily load-shedding in last two months should be provided of each feeder.
 - b) Feeder-wise details of total electricity consumed during last two months.
 - c) Feeder-wise detail of theft of electricity and line losses during the last two years.
 - d) The number of complaints received during last one year regarding overbilling and current status of those complaints.
 - e) Total number of employees including regular, contractual and daily wagers along with their pay-scales.
- IV. Consideration of the report of Mr. Muhammad Ali issued in the year 2020 to the extent of IPPs only.



- V. Compliance report on the directions/recommendations of the Committee in its meeting held on 20th September, 2024 regarding de-linking of dollar and international coal price for determination of price of bagasse being a local raw material/commodity
- VI. The Minister for Power and the Secretary Power Division to brief the Committee on the up to date output of the working of the Task Force in respect of revision/termination of agreements with IPPs with detailed terms & conditions and the deadline for completion of the tasks assigned to the Task Force.


