

REPORT OF THE STANDING COMMITTEE ON LAW AND JUSTICE ON "THE CONSTITUTION (AMENDMENT) BILL, 2021" (INSERTION OF ARTICLE 25B)

I, Chairman of the Standing Committee on Law and Justice, have the honour to present report on "The Constitution (Amendment) Bill, 2021" (Insertion of Article 25B) introduced by Senator Saadia Abbasi, in the Senate sitting held on 27th September, 2021. The Bill, upon introduction, was referred to the Standing Committee for consideration and report.

Senator Saadia Abbasi, Member in-Charge withdrew the Constitutional Amendment Bill, 2021 (Insertion of Article 25B - Right to Nutrition and Food Security), introduced in the Senate on 27th September 2024.
