    - d) All cases of illegal land occupations, scrap cases and action taken against the culprits.
    - e) Briefing by FIA / NAB on all pending cases / inquiries of Pakistan Railways.
  - iii) Detailed briefing / presentation on the following points raised by Senator Kamil Ali Agha in the Committee meeting held on 16<sup>th</sup> August, 2024;
    - a) Steps taken for management improvement and arrangements for security and safety for the commuters.
    - b) Death case of Maryam Bibi of Jaranwala, in which Constable Mir Hassan abused her and her children aboard the Millat Express.
  - iv) Any other item(s) with the permission of the chair.
