SUBJECT: REPORT OF THE SENATE STANDING COMMITTEE ON FEDERAL EDUCATION AND PROFESSIONAL TRAINING ON THE POINT OF PUBLIC IMPORTANCE REGARDING DISCONTINUATION OF ALLOWANCE TO THE PROFESSORS, TEACHERS AND EMPLOYEES OF BUTEMS UNIVERSITY, BALUCHISTAN.

I, Senator Bushra Anjum Butt, Chairperson Senate Standing Committee on Federal Education and Professional Training, have the honor to present report of the Committee on a Point of Public Importance regarding discontinuation of allowance to the professors, teachers and employees of BUTEMS University, Baluchistan raised by Senator Manzoor Ahmed on 5th September, 2024.


3. The Committee took up the matter in its meeting held on 26th September, 2024 which was attended by the following Members:



4. A representative from the Teachers' Association of BUTEMS University, Baluchistan, informed the Committee that despite being one of the largest Universities' in the province, the employees are paid very low pay and allowances. Additionally, many teachers have

not received their salaries for several months, and their house acquisition allowance has been stopped, causing significant hardship for them and their families owing to increased inflation. After that the Chairperson Committee asked the Mover of the Point of Public Importance, Senator Manzoor Ahmed to further explain on the agenda. The Senator expressed his concern, emphasizing the importance of addressing these issues, as many students, including his own children, study there. He further recommended that Federal Government including HEC should increase the University's budget to resolve such problems of teachers and professors. The University's Registrar explained that the issue had not been addressed because an internal meeting of Senate board had not been convened including a court order was issued to stop the allowance for teachers. The Committee directed the Registrar of the BUIITEMS University to hold the Senate meeting within two weeks and share the agenda of University Senate meeting at the earliest, prioritize resolving the pay and allowances issue of the teachers, and report back to the esteemed Committee. The Executive Director HEC was also directed to cooperate and issue a letter to the university, urging immediate action.

5. Thereafter, the agenda was disposed-off. Copy of the Point of Public Importance as raised in the Senate is at Annexure-A. The Committee also gave approval of presentation of report of the Committee to the House. Hence, this report is presented to the House.
