- I. (A) Briefing by the Commissioner, Rawalpindi Division on the latest situation of Constantia Estate, Murree. (B) Efforts made by the **Deputy Commissioner, Murree** for facilitating possession of the property to the M/o. Housing & Works. (C) The DC Murree, in collaboration with the M/o. Housing and Works, shall present drone or ground video of the entire property with audio description to facilitate true assessment and situation of the property. (D) The M/o. Buildings **constructed/approved by Pak PWD/CDA**.

Briefing by the **Chief Commissioner ICT, Chairman CDA, the Inspector General ICT Police** and the DG FGEHA on the coordination, mechanism and strategy in place and the efforts made (under the CDA, ICT and FGEHA regulations/building codes) for removing encroachments and illegally builtup properties in sectors F-12, G-12 and other lands and sectors developed or acquired for the housing schemes of FGEHA in Islamabad.
 - V. Briefing by the **Chairman CDA** and the DG FGEHA; (A) on current water supply situation through tube wells, reservoirs and dams as well as the on-going and future water supply projects, including the one from Tarbella Dam, for the entire ICT in general and the FGEHA sectors/housing schemes in particular; (B) the underground water situation and its quality; (C) steps taken to develop a comprehensive sewerage system for the treatment and disposal of sewage and wastewater instead of draining out in the rainwater channels/nullahs; and (D) plans/policy for the construction of sufficient filtration and purification plants for the drinking water in the ICT and effective maintenance of these plants.
 - VI. Briefing by **DG, FIA** on the details and status of inquiries/cases in FIA against employees, management, contractors, consultants/directors of Pak PWD, FGEHA, PHA-F, NESPAK, Estate Office, and the M/o. Housing & Works since last 10 years.


