

A meeting of the Senate Standing Committee on Poverty Alleviation & Social Safety will be held on 25th April, 2025, at 02:30 p.m. in Committee Room 4, Parliament House Building, Islamabad.

 - ii) "The Bait-ul-Mal (Amendment) Bill, 2024." introduced by Senator Shahadat Awan, in the Senate in its sitting held on 19th February, 2024.
 - iii) Detailed briefing by the Ministry on the district-wise break-up of the budgetary allocation of the four organizations under its ambit with special emphasis on the provinces of Balochistan and Sindh.

 - v) BISP to give comprehensive briefing on Benazir Nashonuma Program: Program components, progress, achievements, modus-operandi of partnerships for execution, details of current partners, including the World Food Program and its operating model for the Program.
 - vi) The Ministry of PA&SS to provide a detailed briefing on financial issues causing hurdles in appointments of BISP vacancies.
 - vii) To review the mandate and scope of the PA&SS Division under "Rules of Business, 1973" for taking the ongoing NPGP and IsDB funded PGP, as well as EU grants to PA&SS, FAO and PPAF and the challenges associated to it for initiation to execute the same by PA&SS Division to become a competitor of its ancillary organizations. The Ministry of PA&SS shall brief about the views of M/o Planning, Development and Special Initiative and M/o Finance on the matter.
 - viii) Detailed briefing by the Managing Director, Pakistan Bait-ul-Maal on the pending projects/cases and action taken for their timely resumption/resolution.
 - ix) Detailed briefing by BISP on the issue of non-profiling of beneficiaries by NADRA despite their eligibility.
 - x) Comprehensive briefing by CEO TVO on the performance of last three years, major achievements, funds utilized, sources of funds, on-going and up-coming projects/plans for under-privileged regions.
 - xi) Any other item with permission of the Chair.
