REVISED NOTICE

Reference Notice dated 12th May, 2025, for the meeting of Senate Standing Committee on **Housing & Works** scheduled to be held on **Tuesday, the 20th May, 2025 at 10:30 a.m.** at Old PIPS Hall, Parliament Lodges, Islamabad (*In case of Senate session in the morning, the meeting will be held at 2:30 p.m.*).

2. **Agenda item No. iii is replaced. Accordingly, REVISED AGENDA of the meeting is appended below: -**

- i. The Secretary M/o. Law and Justice to explain the reasons for non-payment of rent since March, 2021 in respect of the NAB Courts set up in the building of M/o. Housing and Works in Federal Lodge, Wafaqi Colony, Dhana Singh Wala, Lahore and the date the same shall be vacated.
- ii. The Inspector General of the Punjab Police to explain the reasons for illegal possession of the residences of employees of M/o. Housing and Works in Wafaqi Colony, Dhana Singh Wala, Lahore by the Punjab Police in addition to illegal set up of Police Station on 2 residential blocks of the Colony AND non-payment of the rent despite clear orders of the Provincial Ombudsman, Lahore vide Order No. C-7990/2003-ADV-II-481/2003 dated 24th Nov. 2004.
- iii. The Secretary, M/o. Housing and Works and the Commissioner, Rawalpindi Division to brief the Committee on the actions taken in compliance of the directions passed by the Standing Committee in its meeting held on 30th April, 2025 in Murree and in pursuance of the orders passed by the Lahore High Court regarding Constantia Estate, Murree.
- iv. Briefing by the Chairman CDA on the following projects of Pak PWD discussed in the Committee meetings held on 10th September 2024 and 26th March, 2025 respectively:
 - (A) Current status of the Islamabad Jail project.
 - (B) Steps taken to replace the lifts and to carry out the repair and maintenance works in the Shaheed-e-Millat Secretariat, Jinnah Avenue, Islamabad.
- v. Follow up of the following matters discussed in the Committee meeting held on 17th February, 2025.

Briefing by the Chairman CDA on Authority's operations/projects related to FGEHA/PHA-F housing schemes/sectors and the Islamabad Capital Territory:

- (A) Progress made on the project for supply of water to Islamabad from Tarbella Dam and the steps being taken to improve water supply from other sources.
 - (B) Details of projects/plans for the treatment of wastewater and storage/utilization of the rainwater.
 - (C) Status of implementation, monitoring and the issuance and validation of periodical certification of the latest Building Code of Pakistan in public and private buildings as a whole and particularly the life safety measures including fire alarms, fire extinguishers, sprinklers, fire hydrants, emergency exits with indicators, facilities for specially abled persons, monitoring of minimum health safety and sanitation measures to avoid epidemics and viral diseases.
- vi. Briefing by the Secretary M/o. Interior on separate Assignment Accounts of every project of the federal nature for which the M/o. Housing and Works has asked for.
 - vii. The Secretary M/o. Finance may provide details of the funds released against the demands of the M/o. Housing & Works since last 5 years in respect of the PSDP Projects of the federal nature, repair and maintenance for the government buildings including government residences, hostels and federal lodges in the country including funds for the replacement of five lifts and repair and maintenance of Shaheed-e-Millat Secretariat, Jinnah Avenue, Islamabad with reasons and justification for withholding funds against the same.

- viii. The Secretary M/o. Housing and Works may brief and provide the following details on Restoration of Seniority in GWL:
- A) Details of allotments of the government residential accommodations made under Restoration of Seniority since last 2 years giving date of application, name, designation and department of the employee with restored seniority number and justification of the same;
 - B) R&I Diary Number of the first/original application for allotment under GWL along with photocopy of the same.
 - C) The DG Estate and the Incharge Computer Cell / GWL Branch of Estate Office shall certify that the List provided to the Standing Committee about the persons whose seniority has been restored is **complete in all aspects** including verification of all the documents, status of eligibility/entitlement, employment, promotion, posting at the time of initial application as well as on restoration of seniority.
 - D) Audit paras on Restoration of Seniority in the last 2 years and action taken in compliance of the same by the Ministry/Estate Office.
 - E) Composition of the Restoration Committee in last 2 years with name, designation of the Committee members and the rule under which this Committee has been constituted with details.
- ix. Any other matter(s) with permission of the Chair.
