**NOTICE**

A meeting of the Senate Standing Committee on Housing & Works will be held on Wednesday, the 2<sup>nd</sup> July, 2025, at 10.30 a.m. in PRC Hall/ old PIPS Hall, Parliament Lodges, Islamabad. In case of Senate Session in the morning, the meeting will be held at 2:30 p.m.

2. The agenda before the Committee would be as under:-

- (1) The Secretary, M/o. Housing and Works and the Commissioner, Rawalpindi Division to brief the Committee on the actions taken in compliance of the directions passed by the Standing Committee in its meeting held on 30th April, 2025 in Murree and in pursuance of the orders passed by the Lahore High Court regarding the property of M/o. Housing and Works located at Kashmir Point, Murree.
- (2) The Secretary, Ministry of Finance and the Secretary, Establishment Division may explain the reasons for the delay in approving recruitment of personnel essential for the functions and operations of Islamabad Jail.
- (3) The Secretary, Ministry of Planning, Development & Special Initiatives and the Secretary, Ministry of Finance to explain reasons for withholding funds since last 10 years against the following projects (a) originally started by the M/o. Housing and Works (Pak PWD); (b) other projects of CDA primarily related to various completed and ongoing housing schemes/projects of FGEHA, PHA-F; and (c) the buildings of M/o. Housing & Works in Islamabad and other cities:
  - I. Construction of Islamabad Jail;
  - II. Funds for the treatment of sewerage and wastewater as ordered by the Hon'ble Supreme Court of Pakistan;
  - III. Conservation and utilization of rainwater;
  - IV. Replacement of 5 lifts and repair & maintenance works in the Shaheed-e-Millat Secretariat, Jinnah Avenue, Islamabad;
  - V. Repair and maintenance of the buildings owned by the M/o. Housing and Works including office buildings, Govt. residences, and colonies of Fed. Govt. servants, hostels, federal lodges in Islamabad and other cities, particularly Chamba House, Lahore and Qasr-e-Naz, Karachi.
  - VI. Funds for the payment of outstanding and current bills of electricity, gas and water utilities in the federal lodges and hostels of the M/o. Housing and Works in Islamabad and other cities particularly the Chamba House, Lahore and Qasr-e-Naz, Karachi; and funds for the supply of electric appliances including air conditioners, fans, geysers, heaters and other essentials including curtains, carpets, furniture, etc. in these hostels and lodges.
- (4) Comparative statement of existing Accommodation Allocation Rules and the amendments proposed therein OR draft rules to replace the existing AARs and the justification for amendments/revision.
- (5) Any other matter(s) with permission of the Chair.
