
**REVISED NOTICE**

Whether the properties are possessed, acquired by the Ministry of Housing & Works, under litigation, illegally occupied/trespassed or never handed over by the sellers/relevant authorities. Details of payments made for the purchase of these properties.
- (8) Province wise number of applicants on General Waiting List and the allottees of Fed. Govt. residences in each category/type.
