 - iv. Briefing by the Ministry of Foreign Affairs and Ministry of Interior on the current policy regarding extradition to and from other countries along with the country wise details of extraditions during last five years i.e. 30th June, 2020 to 30th June, 2025.
 - v. Briefing by the Ministry of Foreign Affairs and National Disaster Management Authority (NDMA) on the details of humanitarian aid sent to Gaza, Palestine from Pakistan in terms of medicines, hygiene kits, food packs, winterized tents, blankets, and surgical supplies etc. indicating the shipments transmitted so far and the ones in pipeline along-with the timeline by which the next shipment will be delivered.
 - vi. Any other item with permission of the Chair.


