
**NOTICE**

The Hon'ble Chairman Senate referred the Bill to the Committee for consideration and report.
- (ii) Consideration of Point of Public Importance regarding "**low pressure of Gas in Sindh Province, especially in Karachi city**" raised by Senator Nadeem Ahmed Bhutto in the Senate Sitting held on 11-03-2025, referred to the Committee for consideration and report.
- (iii) Briefing by SNGPL on completed, ongoing, and planned development projects/schemes and network expansion in Rawalpindi and Islamabad.
- (iv) Detailed briefing by MD OGDCL on the following: -
  - a) Daily rig rental rates and drilling cost per meter as fixed by the company, including a comparative analysis with rates offered by PPL, Mari Petroleum, and other oil and gas companies for similar wells in both northern and southern regions, along with a detailed explanation for any significant cost disparities observed.
  - b) Total financial loss incurred per day due to forced gas curtailment, including underlying causes, identification of responsible individuals and departments, strategic measures planned by OGDCL to mitigate these losses in the future, and the role of the Petroleum Division in addressing and managing forced gas curtailment.


