 - iii. Comprehensive briefing by the Ministry to the Standing Committee on the following Points:
 - a. The current flood situation and climate emergency in Pakistan including its impact on agriculture as well as on food security.
 - b. Wheat Position in Punjab including border control issues.
 - c. What immediate remedial measures have been taken by the Government of Pakistan in this regard.
 - iv. The Ministry to submit report of inquiry commission regarding import of excessive and unnecessary wheat in the year 2023-24.
 - v. Any other item with permission of the chair.
