Housing & Works by NAB Courts in Lahore without a Rent Agreement and non-payment of rent since March, 2021; and (ii) vacation of the premises by the NAB Courts, Lahore.

 - (4) Briefing by the Chairman CDA, Ministries of Interior, Planning and Finance on following projects of the former Pak PWD (discussed in the Committee meetings held in the past):
 - (i) Current status of the replacement and repair works of the five lifts of Shaheed-e-Millat Secretariat, Islamabad, expected date of completion and the issue of release of funds by the concerned Ministries.
 - (ii) Latest situation of the construction works of Islamabad Model Jail, expected date of completion of the project and the issue of release of funds by the concerned Ministries.
 - (iii) Current status of the construction of apartments in the Ministers Enclave, Islamabad, expected date of completion of the project and the issue of release of funds by the concerned Ministries.
 - (5) Any other matter(s) with permission of the Chair.
