A meeting of the Senate Standing Committee on Interior will be held on **Thursday, the 6th November, 2025, at 11:00 a.m. in Committee Room No. 4, Parliament House, Islamabad. In case of the Senate Session in the morning, the meeting will be held at 02:00 p.m. on the same day.**

2. The agenda of the meeting would be as under:-

- i) **In-camera briefing** by the D.G. FIA (NCCIA) regarding six officers of the National Cyber Crime Investigation Agency (NCCIA), booked on charges of bribery and misuse of power;
- ii) Briefing by the D.G. FIA (NCCIA) regarding personal data of Pakistani citizens and officials reportedly sold online for Rs. 500, triggering national security concerns; also, increasing incidents of cybercrimes, fake calls, and bank frauds affecting innocent people of the country;
- iii) Consideration of Point of Public Importance of Senator Falak Naz regarding financial fraud through fake calls and WhatsApp communication, referred by the Chairman Senate to the SSC on Interior and Narcotics Control on 23rd October, 2025, for consideration and report. Moreover, all those Senators who are affected be invited as special invitees in the meeting;
- iv) Consideration of “The Islamabad Capital Territory Food Safety (Amendment) Bill, 2025” introduced by Senator Samina Mumtaz Zehri in the Senate in its sitting held on 19th May, 2025, and referred to the SSC on Interior and Narcotics Control for consideration and report;
- v) Compliance report of the recommendations in the previous meeting held on 19th August, 2025, regarding “Failure of Police to arrest the murderers of his brother and nephew,” raised by Senator Muhammad Aslam Abro during the sitting of the Senate held on 25th July, 2025, and referred to the SSC on Interior and Narcotics Control for consideration and report;
- vi) Briefing by the Secretary Interior regarding delay in issuance of official gratis Machine Readable Passports for the Hon’ble Members of the Senate and their family members. The Chairman Senate referred the matter to the SSC on Interior and Narcotics Control on 24th October, 2025, for consideration and report on an urgent basis;
- vii) Consideration of proposals for amendment in Schedule-IV of the Passport Rules, 2020, referred to the SSC on Interior and Narcotics Control by the office of the Acting Chairman Senate;

viii) Updates by Chairman CDA on upcoming and future projects for the next one year in Islamabad;

ix) Compliance report regarding the theft case of 2,828 cartons of cigarettes which took place in Swabi, briefed in the last meeting held on 19th August, 2025;

x) Any other item with the permission of the Chair.
