(I) Implementation status on the Federal Cabinet decision notified vide the M/o. Housing & Works Notification dated **6<sup>th</sup> September, 2024** regarding transfer of maintenance staff from Pak PWD to CDA, Estate Office and the other Ministries/Divisions/ Departments of the Federal Government including:

(II) Despite continuous efforts and meetings of the M/o. Housing & Works with the concerned Ministries/Divisions/Departments to expedite implementation on the Federal Cabinet decision:

(A) Reasons for non-implementation and delay by the respective Ministries/ Divisions/ Departments.

(B) Reasons for nonpayment of salaries to the Pak PWD employees since July, 2025 and deliberate delay in seeking funds from the M/o. Finance for FY 2025-26 and subsequent delay by the M/o. Finance in release of requisite funds for the payment of salaries and retirement benefits including Pension, GP Fund, Gratuity, etc.

(C) Payment of salaries and retirement benefits to the Pak PWD Maintenance Staff transferred to CDA in pursuance of the Federal Cabinet decision.

(2) Further consideration of the **Starred Question No.6** asked by **Senator Shahadat Awan** in the Senate Sitting held on **4<sup>th</sup> November, 2025** regarding *"Name and address of the retired Government officers who are currently occupying Government accommodation in Islamabad along with the amount of rent outstanding against such occupants."* referred by the House to the Committee for consideration and report within 60 days.

(3) Further consideration of the **Starred Question No. 69** asked by **Senator Mohammad Humayun Mohmand** in the Senate sitting held on **25<sup>th</sup> July, 2025** (regarding details of bidding process for the award of contract of Lifestyle Residency project) referred by the House to the Committee for consideration and report within 60 days.

(4) Briefing by the MD PHA-F on problems faced by the residents of PHA-F Residencia, Kurri Road, Islamabad on the following issues:

(a) Creating of additional plots/houses on green areas and park sites 15 years after completion of this project in violation of the PAC directives and Wafaqi Mohtasib's judgments.

(b) No regular water supply to the residents, despite collection of full payment for water supply.

(c) Non setup of commercial area of North side despite lapse of 15 years and receipt of full payment for this purpose.

(d) Non installation of Street lights despite receipt of full payment in this regard.

- (e) No construction of School, Community Centre, Health Centre on B.O.T. basis.  
(f) Non-inclusion of residents or Management Committee in planning by the PHAF.  
(g) Handing over of PHA-F Residencia, Kurri Road to the Management Committee after rendition of Accounts to Management Committee.
