

RE-REVISED NOTICE

Reference this Secretariat's Notice of even number dated 23rd January, 2026.  - (iii). Briefing by Petroleum Division on appointment of regular D.G Hydrocarbon Development Institute of Pakistan (HDIP) date of retirement of former D.G., charge period of Acting DG and present composition of HDIP Board of Governors.
