2. The agenda of the meeting scheduled for 4th March, 2026 would be as under: -


- i) Briefing by the DG NIPA, Karachi on the following including the visit:

 - b) Integration of Artificial Intelligence in training programs and the curriculum revisions undertaken during the last two years to align with international standards.
 - c) Engagement with the Government of Sindh, including officer participation, specialized trainings, capacity-building initiatives, and future collaboration plans.

 - f) Number of applications for net-metering pending with NEPRA and their reason and timelines.

 - b) Portion of current gas tariffs representing recoverable losses versus actual cost of supply, measures taken to address these losses.
 - c) Unaccounted-for-Gas losses remain above OGRA benchmarks, what concrete penalties have been imposed on SSGC and SNGPL for non-compliance.
 - d) Has OGRA disallowed any capex for utility non-performance on mandated network upgrades.
- ii) Briefing by the Managing Director NESPAK on the following:
 - a) Current physical and financial progress of the K-IV project, including revised PC-I status, reason for cost escalation and revised completion timelines.
 - b) Current physical and financial progress of the common corridor with KRBT 2.7 km from NIPA to Hassan Square and reason for delay in completion timeline.
